Technical assistance in preparation and implementation of the Sava RBM Plan	 The chronology of the project development is as follows: 14 December – The initial proposal, agreed on the PEG RBM meeting, sent to DG Enlargement (Mr. D'Eugenio); 11-12 February – Meeting with Mr. Romero (DG Environment) who requested the proposal of splitting project budget in the two lines - tender and grant; 29 February – Upon request of the EC, the Secretariat sent a document containing its view on the future project administration and provisional division of tasks between the tender and grant lines (agreed by the PEG RBM), as well as its comments on the upgraded version of the project proposal (OPF Environment Sava River) made by EC; 6-7 March – Beneficiary meeting held in Brussels. The Sava Commission was not invited; 24-25 April – Meeting with Mr. Romero, where further explanations were provided by the Secretariat. The Secretariat asked for urgent information on the project development; 5 May – Mr. Romero sent the two documents: PF_SAVA - FINAL 	Instructions from the EC are expected on: - format of formal confirmation of grant contributions for beneficiary countries; - further development of the project proposal including final divisions of the tasks between grant and tender budget line; - implementation of the grant line of the project.

	 -no FA (proposal developed after the beneficiary meeting – no sugestions of the Secretariat were included) and PF_SAVA - FINAL -no FA_comments D2 (some sugestions of the Secretariat were included); - 14 May – The Secretariat sent to Mr. Romero the two documents (PF_SAVA - FINAL -no FA_comments D2-rev1, and rev2), containing further proposal of the text, as well as Annex V of the proposal with details on the project implementation; - 19 May – The Secretariat received PF_SAVA - FINAL -no FA_comments ENVD2_19May2008, which represents version of the project upgraded by DG Environment and sent to the DG Enlargement (incorporated some of our proposals dated 14 May) - 19 May – Formal acceptance of contributions in ammount of 10 000 Eur per each country received from the Sava Commission members from B&H, Croatia and Serbia. Explanation: As reported on the IX Special Session, the estimated cost of the project is 1.300.000 EUR. The project is planned for financing through "grant" and "tender" lines. About 300.000 Eur is proposed to be a grant to ISRBC, for implementation of certain project tasks to be finally agreed. Requested participation of the beneficiary countries is 10% of the grant amount, 10000 EUR per each country. 	
Hydrology Report for the SRB Analysis	The Terms of Reference was accepted by the Sava Commission at the 9 th Special Session.	At the 9 th Special Session, the Competitive Request for Quotations procedure, in accordance with "Rules of Procurement Procedures" of the Sava Commission, was suggested to be applied for selection of the consultant. The suggested procedure is in preparation.
Development of preparatory documentation for the Joint Sava Survey	 The Consultant (Institute for Biological Research "Siniša Stanković" – IBISS, from Belgrade) has delivered the draft report of the Preparatory documentation for the Joint Sava Survey 2009. The document will be discussed on the 7th PEG APC meeting (June 12, 2008). The document will be used as a basis for the project proposal in scope of the South East Europe Transnational Programme (launched on May 5, 2008). The call for proposals in the SEE Programme will follow a 2-step procedure. For the first step, the Project Proposal Documentation should be sent to the Central Office by June 13, 2008. The project proposal is being prepared by the ISRBC Secretariat and IBISS. 	 At the beginning of September, the joint workshop will be organized by the Secretariat and IBISS. On the workshop, the members of PEG APC, PEG RBM and the ICPDR EG MA (from the Sava countries) will participate and discuss about the detailed programme of the Joint Sava Survey. The workshop, which was previously foreseen for June 12, has been postponed because in August and September, the second step of the call for project proposal of the SEE Programme will take place. The second step will end at the beginning of October 2008.

"Development and Upgrade of the Hydrometeorological Information and Forecasting System for the Sava River Basin"	The National Hydro-Meteorological Services of the Parties (NHMSs) were contacted by the Secretariat with a proposal to prepare a joint project proposal in scope of the South East Europe Transnational Programme, that would include a part of the project "Development and Upgrade of the Hydrometeorological Information and Forecasting System for the Sava River Basin".	
International Contingency Plan for the Sava River Basin	In scope of the call for project proposals for South Eastern Europe, a project proposal for the International Contingency Plan for the Sava River Basin will be prepared. The leading partner is the University of Ljubljana, Faculty for Civil and Geodetic Engineering, and the Sava Commission would participate in the project as a partner. The proposal should be delivered to the central office of the programme by June 13, 2008.

PARTICIPATION IN MEETING	 Through a number of contacts with the ICPDR, made during the reporting period, the following outcomes were achieved: Participation of the ICPDR in the celebration of the Sava Day 2008 was agreed. Technical details related to preparation of the <i>Memorandum of Understanding on Cooperation and Coordination between the ICPDR and the ISRBC</i> for signing, have been agreed. Coordination of meetings of the ICPDR and ISRBC has been ensured. Mutual attendance at the meetings of expert groups has taken place. 	
Meeting with the representatives of the	A meeting with the representatives of the ICPDR and the Danube

	appropriate questionnaire will be prepared.	
	- the DC will organize, in October or November 2008, an expert	
	meeting (workshop), where the questionnaire will be considered	
	and discussed in detail.	
	The representative of DG TREN at the meeting reemphasized the	
	support to the whole process and the implementation of the Statement	
	and expressed the interest to follow up the continuation of the process.	
Meeting with the Energy, Ecology and	A meeting with the Director of the Institute was held on April 17,
