Given the complexity of all aspects of flood risk management in the Sava River Basin and various legal frameworks, this document is not fully aligned with all national documents, Directive on the Assessment and Management of Flood Risks and other valid documents. Introduction

Atlas maps are a spatial view of the thematic layers used during the preparation of the Flood Risk Management Plan in the Sava River Basin. Atlas maps have been prepared mainly for the Areas of Mutual Interest for flood protection in the Sava River Basin.

All maps are in ETRS 1989 LAEA Coordinate system (WKID: 3035 Authority: EPSG) in Lambert Azimuthal Equal Area projection, Central Meridian: 100, Latitude of Origin 520, Linear Unit: Meter (1.0).

The display scale for maps was determined so that content can be placed on the A3 page format (landscape, 42 x 29.6 cm). For maps showing entire area of the Sava river basin was defined scale 1:1,800,000 and for maps showing details was defined scales 1:250,000 and 1:125,000. Details display maps are sorted into pages according to the scheme that is displayed in the Atlas.

The content, spatial layers, shown on the maps were used directly from the central Sava GIS Geodatabase. When creating maps, Esri Basemaps were used in raster format as a background. While developing Flood Risk maps, for Human Health and Economic activity receptors, were used data from Eurostat (Geostat – Population grid 2011) and from European Environmental Agency (Corine Land Cover – CLC 2012).



Areas of Mutual Interest in the Sava River Basin - Scheme of pages




