### Minutes of the meeting

#### AD.1 Opening of the meeting

#### 1.1 Welcome by the Cochairman

#### 2.1 Discussion and conclusions

In discussion following the detailed information on Project provided on the Round Table on Sava GIS (members of Ah GIS EG actively participated on it), the members of Ah GIS EG agreed following:

- final draft reports on "Implementing Documents for Establishment of the Sava GIS" fully respond to the requested tasks;
- members of Ah GIS EG are willing to participate in further activities of establishment Sava GIS (e.g. as a members of Steering Committees). This should be in line with other activities of members of Ah GIS EG related to development of Sava GIS (to avoid any conflict of interest);
- it is of high importance for further development of the Sava GIS to have an employee dedicated to Sava GIS in the Secretariat of the ISRBC. Since this will not be sufficient, some services will, also, have to be outsourced;
- Sava Commission and competent member states Ministries and Institutions are invited to take more extensive part in further development of Sava GIS.
